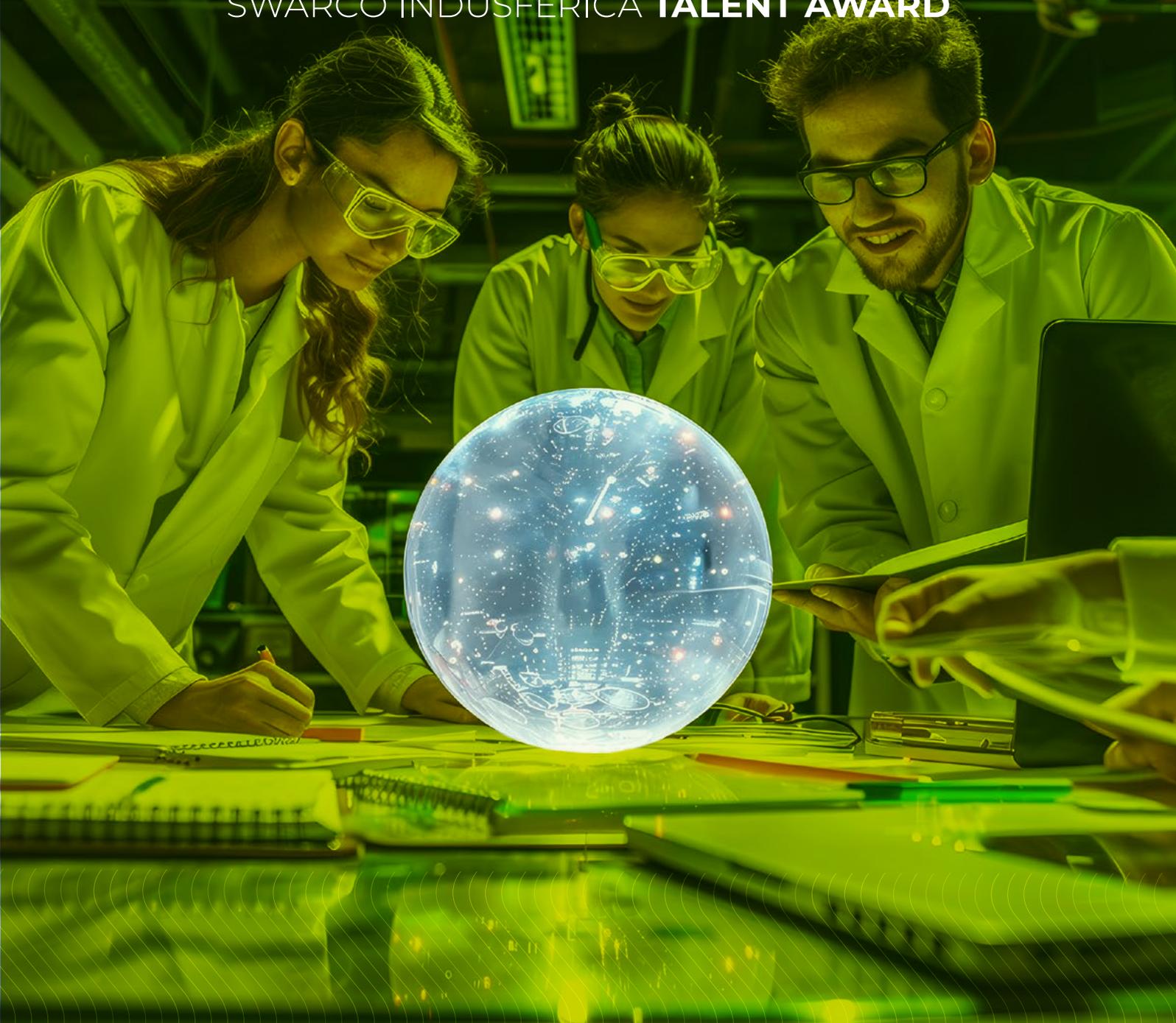

# SWARCO INDUSFERICA TALENT AWARD 24/25

SWARCO Indusferica is presenting the first SWARCO Indusferica Talent Award (SITA) 24/25 to honour excellent researchers for their scientific and technological achievements in applied research in the field of glass beads for industrial applications.

Submissions must describe an innovative idea for the use of glass beads as filler beads in different materials such as plastics and composites, paints, varnishes and coatings, additive manufacturing or 3D printing, or in building materials. Key criteria for the award are innovative strength, sustainability, practicability and benefit for the industry.



## GOAL

Honouring excellent researchers for their scientific and technological achievements in applied research in the use of glass beads for industrial applications

## THE AWARD

The SWARCO Indusferica Talent Award 24/25 will hand out a total of 3,500 euros. The winner of first prize will be awarded 1,500 euros, while the winners of second and third prize will each receive 1,000 euros.

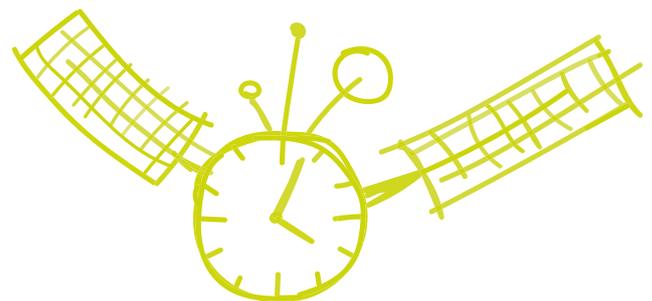

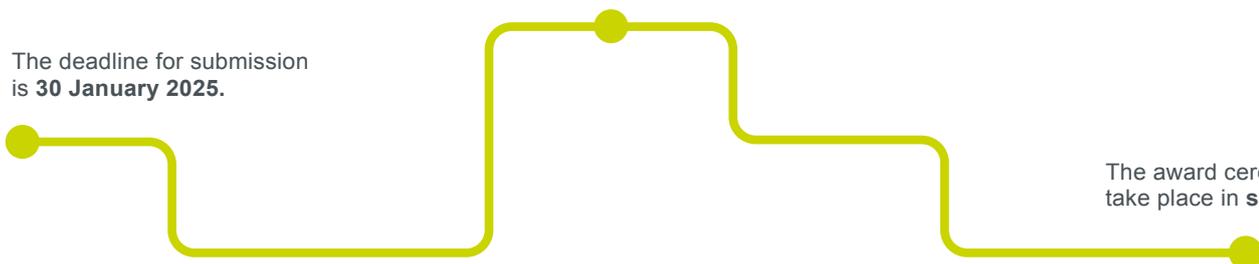


## TIMELINE

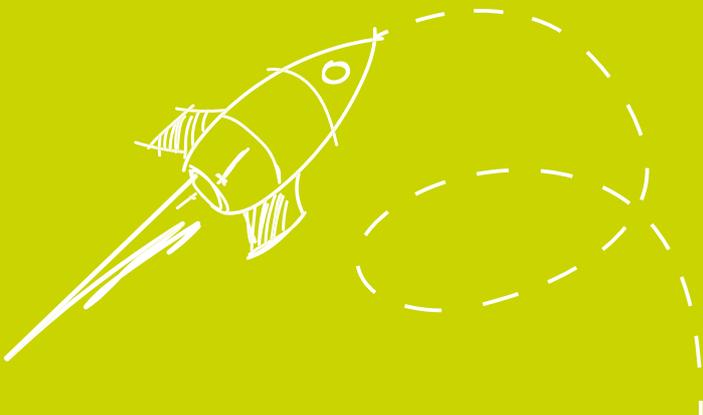

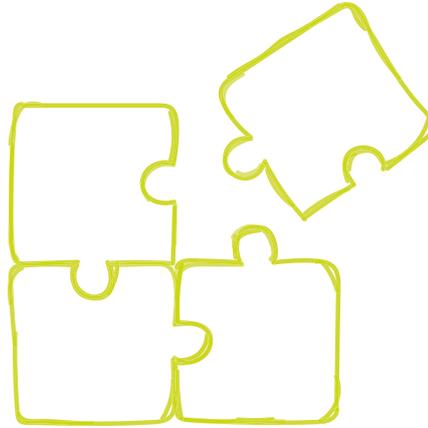

# TERMS AND CONDITIONS OF PARTICIPATION OF M. SWAROVSKI GMBH („SWARCO INDUSFERICA“)

These following Terms and Conditions of Participation stipulate the conditions of participation in the SWARCO INDUSFERICA Talent Award organized by SWARCO INDUSFERICA (hereinafter referred to as the “Competition”). By submitting competition entries, the participants accept any and all conditions set forth in the call and these Terms and Conditions of Participation whilst granting SWARCO INDUSFERICA authorization to use and publish the content submitted without any entitlement to remuneration as set forth in these Terms and Conditions.

## ELIGIBILITY/REASONS FOR EXCLUSION

Participation and submission are restricted to persons who are of age, have authored the document/project submitted (hereinafter referred to as the “Competition Entry”) and who are enrolled at a German-speaking university in Germany, Austria and Switzerland at the time of submission. If the person submitting the Competition Entry is not identical with the person who authored the Competition Entry, the submission must be countersigned by the person who authored the Competition Entry. In the event that an award is conferred, only the person who submitted the Competition Entry will receive the prize money.

Competition Entries shall exclusively be submitted via the official SWARCO INDUSFERICA submission portal. Submissions by post will be excluded. Each participant may submit one Competition Entry only.

SWARCO INDUSFERICA reserves the right to abandon, suspend and/or modify the Competition in whole or in part, for reasons including, but not limited to, fraud, technical malfunctions or any other cause beyond the control of SWARCO INDUSFERICA as may affect the fairness or proper conduct of the Competition.

SWARCO INDUSFERICA also reserves the right to exclude a participant from the Competition at its sole discretion and will not assume any liability for any damage or loss resulting from the modification, suspension or termination of the Competition.

The following persons will be excluded from participation in the Competition as authors or collaborators:

- Persons who have contributed to the preparation of competition documents
- Jury members and their close relatives (spouses, next of kin or in-laws)
- Persons who are professionally dependent on a jury member
- Persons who attempt to influence the decision of a jury member
- Employees of M. Swarovski GmbH and its parent and subsidiary companies as well as the immediate family members (spouses, parents, siblings and children) as well as members of the household of each such employee

Reasons for exclusion from the Competition which emerge during the Competition shall be deemed equivalent with those existing from the beginning.

SWARCO INDUSFERICA will not assume any liability for damage arising from participation in the Competition or the use of the Competition Entries unless such damage is due to intent or gross negligence. There is no legal entitlement to participation in the competition. No recourse to legal action is permitted. Award winners are liable for any and all taxes and fees associated with the conferral and/or use of the prize.
